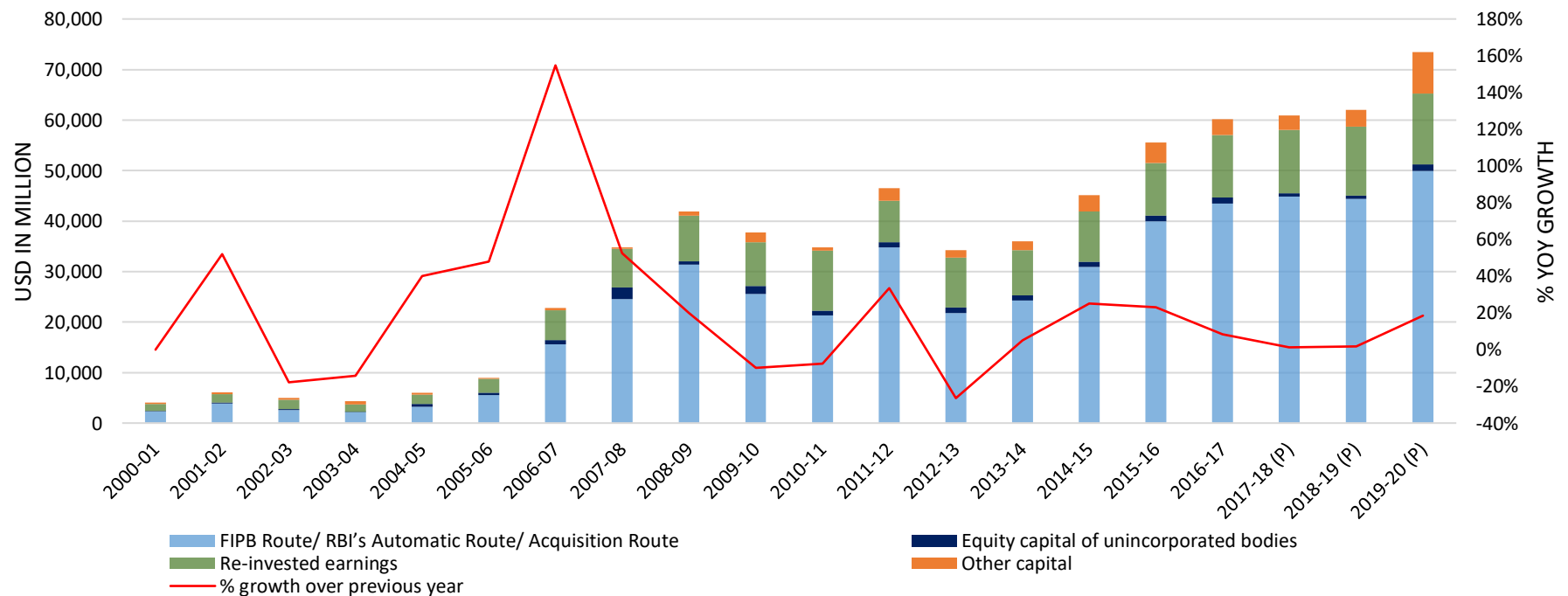


Key Trends of Foreign Direct Investments in India – FY2001 to FY2020



Total FDI's in India have grown at an CAGR of 16% over the past 19 years.

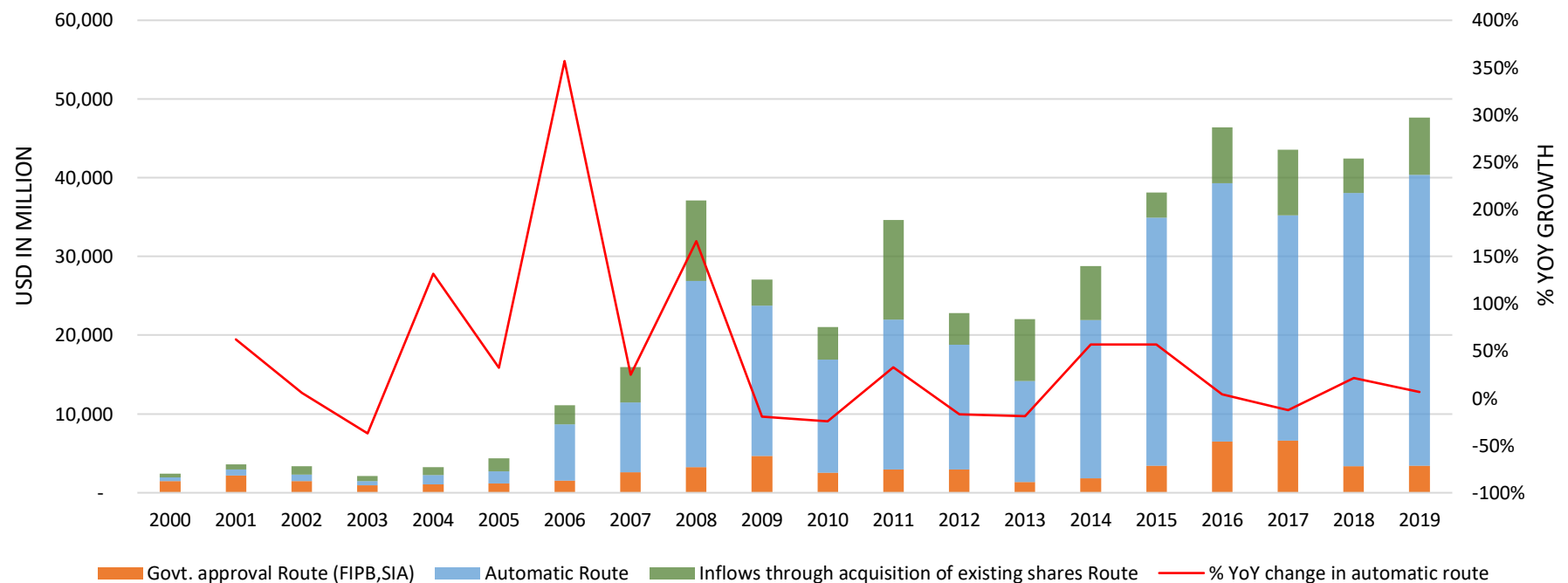
FDI in India - By category - USD in mn - FY01 to FY20
